4. The said firm must ensure that brand new packaging materials are used along with proper labelling mentioning the source of origin tracing upto the farm/ village.
5. The selected firm should be ready to supply the raw materials to Food Park, Nilakuthi.
6. The selected firm must make a security deposit of Rs. 20,000.00 (Rupees Twenty thousand) only.
7. The empaneled firm will be reviewed periodically by a Departmental Committee & for continuation, omission, or addition. The decision of the committee shall be final & binding.
