No. DH&SC-1/973/2026-27: In pursuance of the Secretariat: Horticulture & Soil Conservation Department Letter No. MICE/37/2023-Hand SC-H&SC dated 05/08/2026, read with this Directorate's Notification of even number dated 21/07/2026, and on the recommendation of the Selection Committee, the Overall Combined Merit List of eligible candidates for nomination as State Sponsored Nominees for admission to the 4-year B.Sc. (Hons.) Horticulture Degree Course at various colleges under Central Agricultural University (CAU), Imphal, for the academic session 2026-27, is hereby notified at Annexure-I.

It is hereby informed that, owing to certain technical issues encountered during the counselling proceedings conducted earlier and the consequential seat allotment/result arising therefrom are hereby cancelled and shall have no further effect. Accordingly, fresh counselling shall be conducted for all eligible candidates included in the approved Overall Combined Merit List, strictly in accordance with the merit position and availability of seats.

The fresh counselling shall be held as follows:

- Date: 28th August, 2026
- Time: 11:00 A.M.
- Registration: Candidates shall complete registration by 10:30 A.M.
- Venue: Directorate of Horticulture & Soil Conservation, Sanjenthong, Imphal.

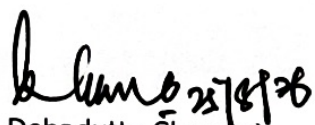
All candidates are required to attend the fresh counselling and produce the original documents and certificates submitted along with their applications for verification.

The selection and allotment of seats shall be made strictly on the basis of the approved Overall Combined Merit List, subject to fulfilment of the prescribed eligibility conditions of the Central Agricultural University and the Government of Manipur. In view of the prevailing law-and-order situation in the State, candidates who are unable to attend the counselling physically may, with prior approval, participate through video conferencing from the concerned District Office, H&SC, subject to verification of the original documents by the concerned District Officer.

Once a candidate accepts the allotted College and executes the Surety Bond, no request for change of college shall be entertained on any ground, including reservation/category claims. In case of cancellation or refusal to join, the candidate shall forfeit all claims to the seat, which shall be allotted to the next eligible candidate in the approved merit list. Failure to attend the fresh counselling either physically or through the permitted video-conferencing facility shall be treated as forfeiture of the candidate's claim to the available seat.

All concerned candidates are advised to remain in contact with the Directorate of Horticulture & Soil Conservation, Sanjenthong, Imphal, and regularly check the Department's official website, www.horticulture.mn.gov.in, for further instructions and updates.
